SEPTEMBER PROGRAM: Chris Turvey of Columbia River Guide Service will be our speaker for September. Chris will present tips and techniques for fall salmon success. Chris is based in Yakima and fishes mainly the Columbia River.

inspect guzzler #6 for a complete refurbish. Zack is going to use this project for his Eagle Scout project. This guzzler is located south east of Benton City in the Horse Heaven Hills. It was completely destroyed by fire. Larry recorded 9 manhours and 52 vehicle miles for the inspection.

GAME RECOVERY:

Larry Martin received a phone call from Washington State Patrol about a road kill on Hwy 240 at the 22 mile marker near Snively Road. Larry found the mule deer doe and with the help of a WSP patrolman, was able to move the deer to a safer location in order to salvage the meat. Larry estimates that approximately 40 pounds were recovered and delivered to the Union Gospel Mission in Pasco.

A reminder that if you come across a fresh road kill game animal and are able, please claim the animal and notify Chris Mosher. Please stay with the animal while waiting for someone from RRGC game recovery to show up. If the animal is seriously injured, inform the local police authority so that they or WDFW can dispatch the animal. A permit must be obtained from WDFW online within 24 hours. If the animal is left on the side of the road, it will be claimed by others and the Union Gospel Mission will not reap the benefit of a resource.

NEW BUSINESS:

1. In a matter that was overlooked last year in 2017, it came to my attention that our own Gene VanLiew was the recipient of a Conservation Special Service Award. Gene was nominated by Benton Conservation District for this statewide award. The award reads as follows: "Gene VanLiew has served as a force for conservation for over two decades. Gene has impacted natural resource conservation in south central Washington by maintaining wildlife guzzlers, servicing wood duck boxes, and participating in bird banding and fish sampling.

Gene is also dedicated to passing on the tradition of conservation. His legacy of service includes educating youth, minorities and underrepresents populations and introducing them to conservation ideals. Since 2003, when he first learned of Benton Conservation District's "Salmon in the Classroom" program, Gene's volunteer commitment has fueled the program's growth from only 5 classes to 180 classes. He is a critical contributor to youth conservation programs that serve over 10,000 youth annually. Gene is an almost relentless advocate for the Benton Conservation District, recruiting and training other volunteers, organizing events, promoting district programs and securing donations, thereby multiplying his individual impact. The breath of his service includes projects and programs with Benton Conservation District, Washington Department of Fish and Wildlife, US Fish & Wildlife Service and nongovernment entities such as Richland Rod & Gun Club and Tapteal Greenway. He is a treasure within the conservation community, a man who gives selflessly of his time and talent."

3. McNary Duck Conservation Day - RRGC is working with staff at McNary Refuge to coordinate a Duck Conservation Day for kids on

Saturday September 8th. Activities proposed include duck banding, retriever dog demonstration, wood duck nest boxes, what do duck eat, and a taxidermist demonstration. - 4. In the August Board Meeting, Mike Estes brought up the subject of RRGC involvement in river shore/habitat development based on the pro/con impacts to our interests as an outdoor organization. Of interest are purchases, sales or transfers of shore line or tracts of habitat. The general theme from the discussion was that RRGC could get involved officially if there was an impact to access to areas that were previously available. Columbia River shoreline in the Tri-Cities was brought up since the property is federally owned but leased to local municipalities. If the transfers to local municipalities were to occur, shore line properties could be sold outright and the public would be denied access. Responses would have to be official based on the situation. Club members have the right to respond personally.
